Notice inviting applications for the allotment of retail sale licenses of Punjab Medium Liquor (L-14A) and Indian Made Foreign Liquor (L-2) in Bathinda District in Punjab for the remaining period from 15-11-2016 to 31-03-2017 for the year 2016-17.

It is notified for the information of general public that the applications for retail sale of PML (L-14A) and IMFL (L-2) in district Bathinda Punjab are invited for the remaining period from 15-11-2016 to 31-03-2017 for the year 2016-17.

The application forms can be obtained from the office of the Asstt. Excise and Taxation Commissioner, Bathinda.

1. Receipt of applications –

- a) Applications may be submitted from 09.00AM till 5.00 PM on 09.11.2016 and 10.11.2016 and submitted from **09.00 AM till 2.00 PM on 11.11.2016. No application shall be received after 02.00 PM on 11.11.2016.**
- b) The application money for one unit with various licensing unit/group/zone sizes will be as below:-

The application money will be non-refundable and non-adjustable.

- c) Applications may be submitted in the office of AETC Bathinda. The application must be accompanied by the application money in the shape of Cash or through Demand Draft, Banker cheques, Pay order or any other pre-paid bank instrument in favour of AETC, Bathinda. The office will give serially numbered receipt to the applicant.
- d) The applications can also be submitted in any of the bank branches authorised by the department. After receipt of application with proper

application money the bank will give a receipt with unique number to the applicant. List of designated branches is as following: -

- e) The applications can also be submitted at a counter in the office of Deputy Commissioner, Bathinda by the AETC, Bathinda.
- The application should be furnished separately for each licensing unit or group or zone as applicable.
 - A person can make any number of applications for any licensing unit without any upper limit.
 - A list of all the applications received shall be displayed after scrutiny at a conspicuous place in the office of the Assistant Excise and Taxation Commissioner, Bathinda on **11.11.2016 latest by 4:00 pm**. Any applicant having any grievance related to displayed list may contact the Deputy Excise and Taxation Commissioner, Faridkot Division, Faridkot personally or by e-mail at detcfdk@gmail.com on 11-11-2016 upto 6:00 PM which shall be disposed off by him and revised list of applications shall be displayed at office of AETC Bathinda by 07.30 PM on 11.11.2016.
 - In case the number of applications is more than the number of licensing units of groups or zones to be allotted in a particular area, the allotment shall be made by draw of lots which will be conducted by a committee consisting of AETC, Bathinda, ETO(X) and Excise and Taxation Inspectors(Excise) of the district in the presence of the media and applicants who wish to be present at the venue. The entire process will be videographed.
 - Draw of lots will be held on **12-11-2016** at 11.00 AM sharp at Daawat Banquet Hall, 80 Feet Road, Bathinda.

8. As per Excise Policy 2016-17 and relevant Rules, the security fee shall be adjusted for the months of January, February and March 2017.
9. The failure to deposit security fee @10% of annual license fee immediately at the time of draw of lots will result in automatic cancellation of the allotment. In that scenario, the waiting candidate will be given a chance to deposit the security fee.
10. After draw of lots, the list of successful allottees shall be displayed at a conspicuous place in the office of Assistant Excise and Taxation Commissioner, Bathinda.
11. The judgment dated 03.11.2016 of the Hon'ble Punjab and Haryana High Court, Chandigarh in CWPs 6558 & 6760 of 2016 will be applicable to the process of re-allotment. Vide Para 62 of the judgment, the Hon'ble High Court has held:-

"Accordingly, the allotment of liquor vends in favour of respondents No. 7 to 9 is set aside. The competent authority is directed to re-allot the vends for the remaining period strictly in terms of the Rules and the policy. The necessary exercise be completed by 13.11.2016. New vends to start operation from 15.11.2016. It shall be ensured that there is no loss of revenue to the State. If any of the vends remains un-allotted in any case, the present allottee shall remain bound to carry on till 31.3.2017."

12. The terms and conditions as mentioned in Excise Policy 2016-17 shall apply along with Punjab Liquor License Rules, 1956 as amended from time to time.
